COUNTY COUNSEL'S IMPARTIAL ANALYSIS OF MEASURE X

A school district may levy a qualified special tax upon approval by twothirds of the votes cast on a measure pursuant to section 4 of article XIIIA of the California Constitution and California Government Code section 50079. The Board of Trustees (Board) of the Evergreen Elementary School District (District) has placed on the ballot a measure to renew an existing \$125 per year parcel tax, which is set to expire on June 30, 2027. If approved by the voters, the renewed tax would commence on July 1, 2027, and continue for seven (7) years from that date.

State law requires such measures to state the specific purposes for which the tax proceeds will be used and that the District spend the proceeds of the tax only for these purposes. The stated purposes of the tax proposed by Measure X are to:

- Protect vital educational programs and classes, including expanding classes for science, technology, engineering, math, visual and performing arts, and music;
- Attract and retain qualified, high-performing teachers, staff, and counselors;
- Support competitive wages and benefits;
- Expand teacher and staff access to resources and training;
- Maintain school facilities, including libraries and media labs; and
- Support campus supervision and student safety measures.

Pursuant to State law, the Measure provides additional accountability measures for the proceeds, including (1) depositing the proceeds into a fund that is separate from other District funds, and (2) providing an annual written report to the Board detailing the amount of funds collected and expended and the status of any projects or description of any programs required or authorized to be funded under this Measure. The Measure states that the Board will establish a citizens' oversight committee to review expenditures of the tax proceeds and ensure they are applied only to authorized purposes.

The Measure states that the proposed tax does not apply to any parcel that is owned and occupied by persons (1) 65 years of age or older as of July 1 of the tax year; (2) receiving Supplemental Security Income for a disability, regardless of age; or (3) receiving Social Security Disability Insurance benefits, regardless of age, whose yearly income does not exceed 250 percent of the 2012 federal poverty guidelines issued by the United States Department of Health and Human Services. According to the Measure, the proposed tax also does not apply to property that is otherwise exempt from property taxation, or on which no property taxes are levied in that year.

A "yes" vote is a vote to renew an existing tax of \$125 per parcel on parcels within the District for seven years, beginning on July 1, 2027.

A "no" vote is a vote to not renew the tax.

COMPLETE TEXT OF MEASURE X

EVERGREEN ELEMENTARY SCHOOL DISTRICT EDUCATION AND LOCAL FUNDING MEASURE OF 2024

This Measure may be known and referred to as the "Evergreen Elementary School District Education and Local Funding Measure of 2024" or as "Measure X".

TERMS AND PURPOSES

Terms. Upon approval of two-thirds of those voting on this measure (this "Measure"), the Evergreen Elementary School District (the "District") shall be authorized to continue to levy a qualified special tax (the "Education Parcel Tax") in the amount of \$125 per year on each parcel of taxable real property in the District for no more than seven (7) years, commencing July 1, 2027, upon the expiration of the existing education parcel tax approved by the voters of the District in 2018.

<u>Purposes</u>. The proceeds of this Measure shall be authorized to be used to (a) protect vital educational programs and classes, including expanding classes for science, technology, engineering, math, visual and performing arts, and music, (b) attract and retain qualified, high-performing teachers, staff and counselors, (c) support competitive wages and benefits, (d) expand access to resources and training for teachers and staff, (e) maintain school facilities, including libraries and media labs, and (f) support campus supervision and student safety measures, and not for any other purpose.

Exemptions from Qualified Special Tax. In order to provide tax relief, any parcel owned and occupied by the following taxpayers shall be exempt from the Education Parcel Tax upon proper application to the District: (a) persons who are 65 years of age or older as of July 1 of the tax year; (b) persons receiving Supplemental Security Income for a disability, regardless of age; and (c) persons receiving Social Security Disability Insurance benefits, regardless of age, whose yearly income does not exceed 250 percent of the 2012 federal poverty guidelines issued by the United States Department of Health and Human Services. The exemptions shall be available pursuant to procedures to be prescribed by the Board of Trustees of the District (the "Board of Trustees") or otherwise as required by law or by the Tax Collector (the "Tax Collector") of the County of Santa Clara (the "County").

Appropriations Limit. The District's annual appropriations limit shall be raised in each year the Education Parcel Tax is authorized to be levied in the amount of the funds raised by the Education Parcel Tax in such year.

ACCOUNTABILITY PROVISIONS

Independent Citizens' Oversight Committee. The Board of Trustees shall establish an independent citizens' oversight committee comprised of such members as the Board of Trustees shall determine to review expenditures of the proceeds of the Education Parcel Tax to ensure that such proceeds are applied only to authorized purposes.

Separate Account: Annual Report. Upon the levy and collection of the Education Parcel Tax, the Board of Trustees shall cause an account to be established into which the proceeds shall be deposited. For so long as any proceeds remain unexpended, the Superintendent of the District shall cause a report to be filed with the Board of Trustees at least once a year, stating (a) the amount collected and expended in such year, and (b)

the status of any projects or description of any programs required or authorized to be funded under this Measure. The report may relate to the calendar year, fiscal year, or other appropriate annual period as the Superintendent of the District shall determine, and may be incorporated into or filed with the annual budget, audit, or other appropriate routine report to the Board of Trustees.

<u>Use Limited to Specific Purposes</u>. All of the purposes named in this Measure shall constitute the specific purposes of the Education Parcel Tax, and proceeds of the tax shall not be applied for any other purposes.

LEVY AND COLLECTION

The Education Parcel Tax shall be collected by the Tax Collector at the same time and manner and shall be subject to the same penalties as ad valorem property taxes collected by the Tax Collector. Unpaid taxes shall bear interest at the same rate as the rate for unpaid ad valorem property taxes until paid. The collection of the Education Parcel Tax shall not decrease the funds available from other sources of the District in any period from the effective date hereof.

"Parcel of taxable real property" shall be defined as any unit of real property in the District which receives a separate tax bill for *ad valorem* property taxes from the Tax Collector's Office. All property which is otherwise exempt from or on which are levied no *ad valorem* property taxes in any year shall also be exempt from the Education Parcel Tax in such year. Any parcel owned and occupied by the following taxpayers shall be exempt from the Education Parcel Tax as provided in this Measure: (a) persons who are 65 years of age or older as of July 1 of the tax year; (b) persons receiving Supplemental Security Income for a disability, regardless of age; and (c) persons receiving Social Security Disability Insurance benefits, regardless of age, whose yearly income does not exceed 250 percent of the 2012 federal poverty guidelines issued by the United States Department of Health and Human Services.

The District shall annually provide a list of parcels which the District has approved for an exemption from the Education Parcel Tax to the County tax collection officials and otherwise comply with the provisions of Section 50079 of the California Government Code. The County Assessor's determination of exemption or relief of any parcel from taxation for any reason other than the exemptions provided for in this Measure shall be final and binding for the purposes of the Education Parcel Tax. Taxpayers wishing to challenge the County Assessor's determination must do so under the procedures for correcting a misclassification of property pursuant to Section 4876.5 of the California Revenue and Taxation Code or other applicable procedures. Taxpayers seeking a refund of Education Parcel Taxes paid shall follow the procedures applicable to property tax refunds pursuant to the California Revenue and Taxation Code.

SEVERABILITY

The Board of Trustees hereby declares, and the voters by approving this Measure concur, that every section and part of this Measure has independent value, and the Board of Trustees and the voters would have adopted each provision hereof regardless of every other provision hereof. Upon approval of this Measure by the voters, should any part be found by a court of competent jurisdiction to be invalid for any reason, all remaining parts hereof shall remain in full force and effect to the fullest extent allowed by law.
